**MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is made on 03<sup>rd</sup> January 2022 between **G. Kuppuswamy Naidu Memorial Hospital, Coimbatore**, which is represented by its Chief Executive Officer Dr. Ragupathy Veluswamy here in named as 1<sup>st</sup> Party (hereafter called GKNMH) and **JSS COLLEGE OF PHARMACY, UDHAGAMANDALAM (OOTY)** represented by its Principal herein named as 2<sup>nd</sup> Party (hereafter called JSSCPO).

The parties hitherto agree as follow:

1. Whereas GKNMH is a 532 bedded Hospital for General Medicine Department with specialization of Oncology and Cardiology.
2. Whereas GKNMH agrees to provide Intensive Clinical Training Programme cum Six months Project Study for 5<sup>th</sup> Year Pharm.D Programme at their Hospital premises.
3. Whereas GKNMH agrees to provide Preceptors required in/for the training the Pharm.D Students by coordinating with faculty of JSSCPO.
4. The Prospective Students will be allowed to undergo Training cum Project Study in the following Specialties:-

1. Intensive Care areas / Obstetrics & Gynecology
2. Oncology Counseling at Discharge / Out-Patient Department
3. Cardiac ICU / Anti coagulation Clinic / Cardiology / Orthopaedics
4. Paediatrics, PICU, NICU Counseling at Discharge / OPD
5. Patient Counseling in Retail / Inventory Control / Labeling



5. Whereas JSSCPO will provide the Required Academic Staff for Training Programme and takes the overall responsibility for the smooth conduct of the Programme.
6. This memorandum of understanding is to be in effect for the period of two years from the time of its endorsement by both the parties.
7. The Official Representing GKNM Hospital and JSS COLLEGE OF PHARMACY, OOTY are signing this MOU to achieve the beneficial objective of Training Programme and Project study.
8. Sixth year Pharm.D students to be placed for their clinical internship programme at various wards of the hospital for the period of 2 months which will be supervised and guided by a preceptor at GKNMH who will be the physician.
9. A party may terminate this Memorandum of Understanding for convenience and at any time and for any reason by giving three months' notice in writing to the other party.
10. In the event of any doubt, difference, or dispute in the interpretation or implementation of the agreement or any matter concerning or arising out of this agreement, the same shall be at the first instance tried to be amicably sorted out between the parties here to and on failure, the same shall be referred to a sole arbitrator to be mutually agreed upon for arbitration to be held at Coimbatore and the decision of the sole arbitrator on all matters so referred shall be final and binding upon the parties. The Laws of India shall apply to such arbitration and the courts at Coimbatore only shall have jurisdiction.
11. This Agreement shall be governed by and construed in accordance with Indian Law and the courts at Coimbatore only shall have jurisdiction.
