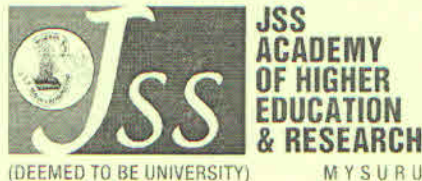

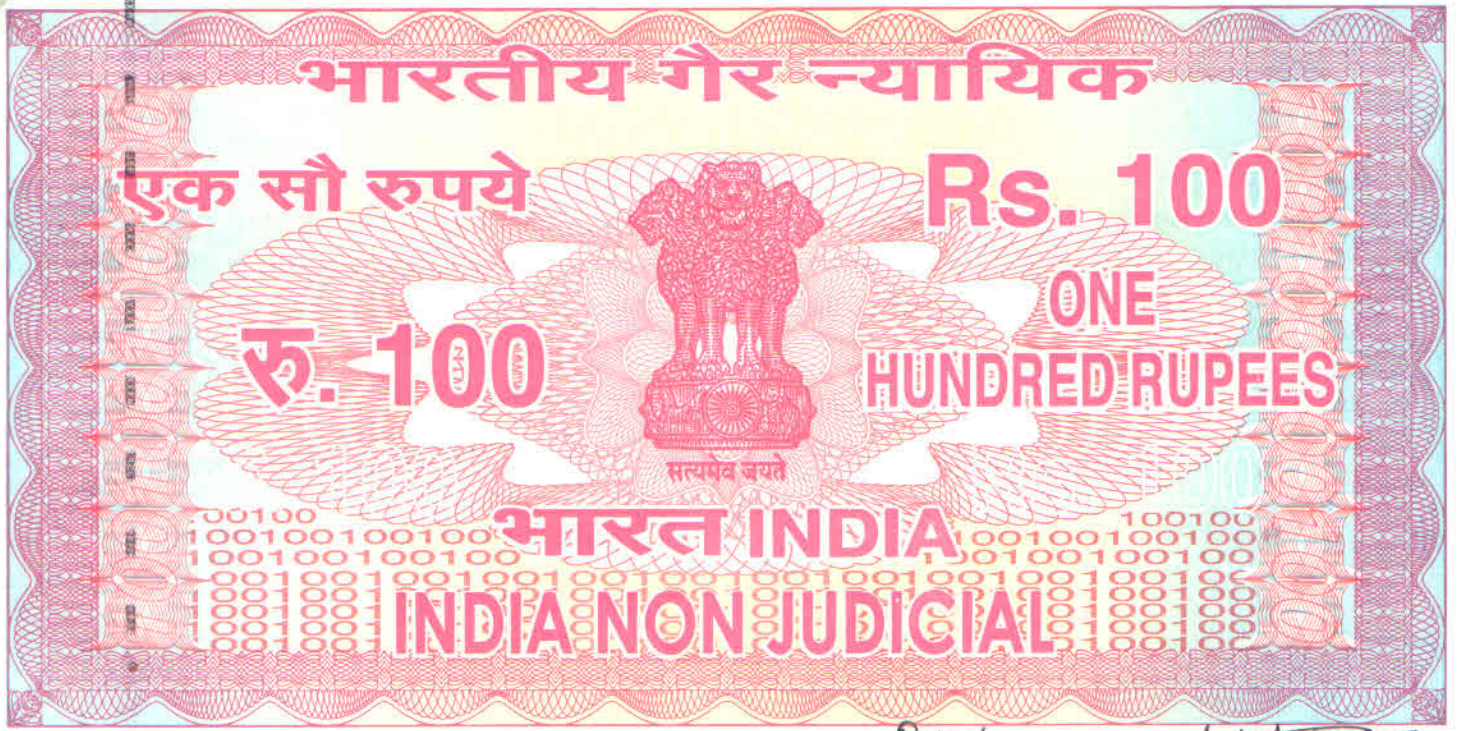

This MEMORANDUM OF UNDERSTANDING ("MOU") is executed on this 1st April 2022 by and between:

- VGM Hospital, Coimbatore - a dedicated gastroenterology hospital having its premises at # 2100, Trichy Road, Rajalakshmi Mills Stop, Coimbatore - 641 005 (hereinafter referred to as "VGM Hospital"),
- JSS College of Pharmacy, Ooty - a constituent college of JSS Academy of Higher Education & Research, Mysuru and having its principal office at Rocklands; Ooty (hereinafter referred to as "JSSCPO", which expression shall, unless repugnant to the meaning and context thereof, be deemed to include its successors and permitted assigns), of the **SECOND AND THE LAST PART**.

VGM Hospital and JSSCPO may hereinafter collectively be referred to as the "Parties" and individually each of them may be referred to as a "Party".

This MOU focuses on the following areas:

1. Student inplant training and internship in various departments
2. Students project course work for duration of 6 months to a maximum of 4 years
3. Interaction between students and staffs with industry personnel through guest lectures, conferences and symposium
4. Knowledge upgradation over recent trends in area of research through faculty training and through R&D Cell.
5. Students placement based on the availability.

Now the Memorandum of undertaking witnessth as follows;

The party having desire of providing

(a) Co-operation and joint training of

(i) Pharm D students of JSSCPO at the premises of the **FIRST PART** by the Physicians / Clinicians / Pharmacists. This training shall include clinical pharmacy /hospital pharmacy activities at various specialty clinical settings viz., Endocrinology, Oncology, Orthopaedics, Urology, Nephrology, Gastroenterology and Plastic, Reconstructive and Cosmetic Surgery etc. depending on the request from SECOND PART and feasibility to accommodate by FIRST PART and

(ii) Pharmacists / PG students of VGM Hospital by the faculty members of SECOND PART in areas predetermined by both the parties from time to time.

(b) Co-operation for the placement of Pharm D graduates of JSSCPO at suitable positions available from time to time in the organizations of FIRST PART binding to the terms and conditions of FIRST PART from time to time

(c) Co-operation and joint academic research (dissertation / thesis either in part or as a whole) leading to the award of Post Graduate degree / PhD degree as per the rules and regulations of the JSS University. Such other research activities as may be mutually agreed upon in writing between the PARTIES from time to time.

RELATIONSHIP OF PARTIES

The Parties shall act in their independent capacities in the performance of their respective functions under this MOU and no Party shall be considered as an officer, agent or employee of the other Party.

TERM AND TERMINATION




