



#### **Objective of International Student Cell Committee**

c) Shall sensitize the newly enrolled international students on the existence, functioning and role of the cell and also share with them the mode of contact in case of grievance.

d) Conduct two/three meeting in a year in the presence of the Student Representatives to cater to their grievances.

e) Integrate International Students into the college premises and activities without any obstacles.

f) Address the grievance of International students with respect to Academics, Accommodation, Admission, Evaluation or any other issues during their stay.

g) To provide the Students with information about the local customs, language and civic facilities.

JSS AHER ODL uses various modes of technology for effective delivery of the curriculum and efficient learning of the learners. It has established two study centers, one in Bengaluru and another at Ooty, to facilitate enhanced learning and provided additional support to the students. It has also having collaborations with other partners whose aim is also to empower the students by distance learning.

Students have exclusive hostels for Boys and Girls with spacious, comfortable, well-furnished rooms with all modern amenities, hygienic kitchens, nutritious food, and portable RO water source is provided for drinking. Each hostel block has a separate pantry and laundry facility. Students wishing to stay in these hostels are advised to apply in the prescribed forms. The boarders are having Indoor and outdoor sports facilities and ample reading room facility. Round the clock security guards (Male & Female for respective hostels) as well as CCTV cameras are placed for continuous monitoring and vigilance for the safety of students.

### OUTREACH ACTIVITIES SUPPORTING SDG 10 COMPREHENSIVE GERIATRIC CARE SERVICES THROUGH HOME VISITS

Department of Geriatrics, JSS Medical College and hospital, provides Comprehensive health care is provided to elderly through home visits at an affordable cost. Faculty in the Department of Geriatrics along with nursing staff, technicians and counsellor visit the houses of elderly and provide the health services. Four types of services namely, doctor consultation, physiotherapy, diagnostic test and nursing services are provided at the doorsteps of elderly. Follow up visits are conducted at regular intervals to assess the prognosis and provide the support in medication management. Teleconsultation with a dedicated helpline is made available to provide the services round the clock.

During the visit elderly are educated on prevention of falls, diet and physical exercise, adherence to medication, mental health and wellbeing, substance abuse, life style modification, danger signs related to myocardial infarction, cancers and stroke. 75 to 100 houses are visited monthly under this initiative.

#### SPECIAL OLYMPICS BHARAT



Special Olympics Bharat is a National Sports Federation also registered under the Indian Trust Act 1882 in 2001 and is accredited by Special Olympics International to conduct Special Olympics Programs in India. It is recognized by the Ministry of Youth Affairs & Sports, Government of India as a National Sports Federation in the Priority Category, fordevelopment of Sports for Persons with Intellectual Disabilities, and is a designated Nodal Agency for all disabilities on account of its national presence and experience, especially in rural areas which account for nearly 75 per cent of the disabled population in India.

An all-India event was organized on 5th April 2022 and 7th April 2022. The target was to screen 75000 children with the help of 7500 doctors in 75 cities on 7th April 2022 to celebrate 75th Azadi ka Amrit Mahotsav.

The JSS team was provided Prerana trust Fund in mandya as the venue.

Prerana Trust for the Disabled at Mandya is running a free boarding hostel for the blind and physically challenged students. 24 were blind, 21 were speech and hearing impaired, 13 were with various physically challenged among them. All are given free education boarding's hostel to stay and school uniforms and all other basic amenities with free of cost (under the Progressive Educational Training) with help of a generous donation by the public and other phylum Homopists and educationists with liberal donation.

On 5th April 2022, a team of interns and pgs with Dr.Nandlal and Dr. Reshma had gone to inspect the venue.

On 7th April 2022, 48 dental volunteers (faculty, interns and pgs) from JSS Dental College and few volunteers from diet and nutrition department of JSS Medical College reached the venue around 9am.

The children were called from various schools like JSS School, Aashna Sadan etc. Once the children were brought their id cards were scanned and a brief screening was done. A HASS form was taught to the dental volunteers during the training program (21-25th march 2022).

Various variables like untreated decay, missing teeth, injury, restorations were evaluated and recorded in the form. The program was from 9am to 1pm. After which the children and the team were provided with lunch. At Mandya center, 110 children were screened by the dental team. All India, 93954 kids were screened out of which 52,464 underwent dental screening.

# WORLD ORAL HEALTH DAY 2022 - BABY ORAL HEALTH PROMOTION CLINIC



Baby Oral Health Promotion Clinic" an extension clinic of Dept of Pediatric and Preventive Dentistry at Dept of Pediatrics, JSS Hospital, is providing preventive and interceptive oral health care for infants and young children since its inception in 2014.

On the occasion of World Oral Health Day 23-03-2022 with the theme Be Proud of Your Mouth" an orientation and awareness program was conducted for Interns of JSS Dental College and Hospital, from Baby Oral Health Promotion Clinic. Dr Nandlal B Professor & Head, Dept of Pediatric and Preventive Dentistry inaugurated the program and Dr Indira MD, coordinator of Baby Oral Health Promotion Clinic provided information on importance of baby oral health care and inception of Baby Oral Health Promotion Clinic to all the interns. A pre and post survey was conducted to assess the knowledge of interns on baby oral health care.

#### **ORAL GERIATRIC GYAN**

The Staffs & PGs of Department of prosthodontics organised a webinar on the theme "Oral Geriatric Gyan - 2021" with the objective to create insights about oral health in geriatrics patients. The webinar was coordinated by Dr.Sowmya.S, and webinar was in collaboration with Geriatric Medicine (JSSMC). There were 195 registrations for the webinar. The resource person for the webinar were Dr. Pratibha Pereira, Prof & HOD, Dept of Geriatric Medicine, JSSMC, Dr. Pampanagouda SKM, Consultant oncologist, Fortis Health care, Banglore, Dr.Dhakshaini M.R, Deputy Director (Authorities), JSSAHER and Panelists were Dr. Ganesh S, Reader, Dept of prosthodontics, JSSDC&H Dr. Sanjay CJ Reader, Dept of OMR, JSSDC&H and Dr. Raghavendra Swamy KN, Professor, Dept of prosthodontics, JSSDC&H respectively. The programme started with talk by Dr Pratibha Pereira on "Geriatricians key role in oral Health" followed by welcome address from Dr.Raghavendra Swamy KN Professor & HOD,Dept of Prosthodontics,JSSDC&H in the inaugural ceremony. The chief guest for the webinar was Dr. Kushallapa PA, Director Academics and guest of honour were Dr Ravindra S, Principal and Dr Chandrashekar B R, Vice Principal, JSSDC&H. This was followed by a talk on "Tobacco: A bane for the elderly" by Dr.Pampanagouda SKM and "Geriatric Prosthodontic care: Don't stay unaware" by Dr. Dhakshaini M.R. There was an enriched discussion after each talk followed by question & answer session and the webinar was well appreciated by the participants and the invitees.

#### **OUTREACH ACTIVITIES**

1) Dr Ratnamma S working as Scientist C under Dr.Deepa Bhat, Department of Anatomy has been working for "Improving the capacity of health system in screening and management of sickle cell disease" as a part of National Task Force for Sickle cell disease has been recognized as **Deccan Herald change maker**. First women PhD holder working towards betterment of the tribal community especially women empowerment and Sickle cell disease. She has been supporting education of several children.

2) Dr Tejaswini, Department of Geriatrics, a past member Ladies circle India in collaboration with the present members have donated wheelchairs every month to needy elderly.

**3) DST-STUTI awareness programme**, was a Department of Science and Technology (DST), Ministry of Science and Technology, Govt. of India sponsored science exhibition fair conducted for the school children across Mysuru & Chamarajanagar District. JSSAHER is the only one from the State, out of 13 across the country, selected to participate in the STUTI project. It was the first of its kind and was conducted between 22 February to 28 February 2022. Science fair was conducted at JSS Women's colleges & JSS High schools along with Govt. school of Varuna and JNV Mysuru.

**Science-on-Wheels** is a unique bus that contains research-related equipment such as the world's smallest and most portable live-cell imaging microscope (cytosmart), cancer cell lines, pH meters, colorimeters, micropipettes, and anatomical models of human organs. In addition to providing awareness on Science and Research to the interested public, this bus is internet-enabled and can stream programs anywhere in the world live. The Science-on-Wheels vehicle travelled around the district for a week, educating rural populations about science.

As part of this week-long event **National Science Week-2022**, there were Science workshops, a Science expo, and lectures on Science to raise awareness on Science and Research among students from High Schools, Colleges, and women in rural & tribal areas.

All the departments of JSS Medical College had their respective stalls with the specimens, instruments, models, charts etc. for demonstration to the students.

## Policy on antidiscrimination in the workplace

## 1. Preamble

JSS Academy of Higher Education & Research, believes in equality in workplace. Hence, the HEI has made this policy to prevent any discrimination and ensure equality.

## 2. Definition:

**Discrimination** in workplace can be in different forms; there might be a single reason or a combination of multiple grounds of discrimination. Discrimination in a workplace may constitute in form of:

- 5. Pregnancy
- 6. National origin
- 7. Race/ Colour
- 8. Religion
- 9. Sexual harassment
- 10. Equal pay or compensation
- 11. Region/Place of origin
- 12. Caste and
- 13. Ethnicity.

### 3. Procedures:

### **3.1 Disability**

Disability discrimination occurs when an employer or an entity treats a qualified individual with disability who is an applicant or employee unfavourably due to that person being disabled. This unfavourable behaviour can be experienced during recruiting, pay, promotion, etc.

JSS Academy of Higher Education & Research has made a commitment for promoting, protecting and ensuring the rights recognised by government of India's act -The rights of Persons with disabilities Act, 2016 for **safeguarding** and **protecting** the disabled in India.

This Act under Sec. 3 mentions that 'No person with disability shall be discriminated on the grounds of disability and ensures that the person with disability enjoys the right to equality, life with dignity and respect for his/her integrity equally with others.

Under Sec. 19 and 20 there shall be non-discrimination in employment.

Under Sec. 32 of the same Act provides for reservation in higher educational institutions.

Under the Act, Sec. 34 the following categories of benchmark 'disabilities' are protected – (a) Blindness and Low vision; (b) Deaf and hard of Hearing impairment; (c) Loco motor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (c) Autism, intellectual disability, specific learning disability and (d) Mental illness Multiple disabilities from amongst persons under clauses a to d

JSS Academy of Higher Education & Research abides by this ACT

### **3.2 Remuneration**

Discrimination may also exist in the payment of compensation to the employee which includes salary and other benefits. JSS Academy of Higher Education & Research shall not show any such discrimination.

### **3.3 Principle of Equal pay for Equal work**

JSS Academy of Higher Education & Research shall pay equal remuneration to men and women workers for same work or work of a similar nature as per the **Equal Remuneration Act, 1976. Section 5** of the Act and shall **prohibit** formulating a recruiting process putting women on disadvantage on account of their gender which is in reference to the work that is same or similarto that which is offered to men and even in respects of transfers and promotions.

### **3.4 Discrimination based on sex**

Discrimination based on sex can happen when an employee or a probable candidate is discriminated on the grounds of a person belonging to a particular sex. Discrimination based on sex might be seen in the areas of recruiting, conditions of employment, promotion, benefits, dividing work tasks based on whether staffs are male or female.

Any such discrimination shall be prohibited at JSS Academy of Higher Education & Research.

Discrimination on this ground is **prohibited** by **Article 15** of the Constitution which says no citizen shall on the grounds of sex, caste, place of birth be ineligible for, or discriminated against in respect of, any employment or office.

### **3.5 Discrimination on the grounds of pregnancy**

Discrimination can be refusal of grant of job to a women who is pregnant or dismissal of the women from the organisation subject to her disclosure of the fact of pregnancy.

Such a discrimination shall be prohibited at JSS Academy of Higher Education & Research.

### **3.6 Discrimination based on caste**

Under the Protection of Civil Rights Act, 1955 and the protection of civil rights rules 1977 if a person molests, injures, annoys, boycott, obstructs, or insults or attempt to do such act toward a person of Scheduled Caste, that person may be punished with imprisonment of term not less than one month and may extend upto six months and with fine not less than one hundred rupees and not more thanfive hundred rupees. If a person of Scheduled Caste faces boycott in form of not allowing that person to work or do business with other person or receive from him the services he renders, or any other things which are commonly done in ordinary course of a business is a punishable offence and he may file a FIR in the local police station.

Such a discrimination shall be prohibited at JSS Academy of Higher Education & Research.

### 3.7 Prevention of sexual harassment of women:

JSS AHER strictly prevents, prohibits and redresses sexual harassment of women as per Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal) Act, 2013. As per this Act under Sec.4 an internal compliance committee shall be constituted for the purpose.

The admission policy of JSS AHER are framed from time to time based on the by-law of the JSS Academy of Higher Education & Research, as approved by the authorities of the JSS AHER and are in compliances with various directions and regulations:

- > The Hon'ble Supreme Court of India.
- The University Grants commission (UGC).
- > The National Medical Commission (NMC).
- The Dental Council of India (DCI).
- The Pharmacy Council Of India (PCI).
- The All India Council for Technical Education regulations (AICTE)
- > The Rehabilitation Council of India (RCI)
- > The Atomic Energy Regulatory Board (AERB) and
- > The JSS Academy of Higher Education & Research regulations.



### **Policy**

### **Principles** of selection

JSS Academy of Higher Education & Research is committed to maintaining internationally recognized high academic standards in its courses. To this end JSS AHER:

- a) Selects students from among the pool of applicants those who are deemed most likely to be able tosucceed in its courses; and
- b) Selects academically capable students into research programs only where appropriate supervisory expertise and resources are available.

### Minimum entry requirements:

JSS AHER approves minimum entry requirements and English language requirements for courses.

- 1. Minimum entry requirements are set ensure that a student is only admitted to a course when the JSS AHER believes that the student can undertake the course with a reasonable prospect of success.
- 2. Minimum entry requirements for consideration for selection, including the English language requirements are published on the JSS AHER's website and in the Information Bulletin.
- 3. Meeting the minimum entry requirements allows an applicant to be considered for selection.
- 4. Minimum entry requirements are specified in the relevant course approval instrument approved by the UGC/MCI/DCI/PCI/AICTE/RCI/AERB/JSS AHER and Hon'ble Supreme Court of India.
- 5. The criteria for minimum entry requirements are approved in the Academic Council & Board of Management and same is provided on JSS AHER website and in the Information Bulletin.
- 6. When approving minimum entry requirements, JSS AHER Counseling / Selection committee to see:



- a) Evidence-based selection;
- b) No unfair or unnecessary barriers for student access to JSS AHER courses;
- c) Facilitation of recognition or credit of prior study or work experience for entry into JSS AHER's courses;
- d) Clear and consistent selection requirements that are appropriate to the level of the relevant course within the Indian Qualifications; and
- e) Clear and consistent information for applicants of non-academic requirements for entry, including regulatory requirements, Police checks and Working with Children checks, where required.
- 7. JSS AHER Counseling Selection Committee will monitor the admission process for effectiveness and appropriateness of minimum entry requirements.

### Transfer between courses

- 1. JSS AHER authority and concerned college Principal may approve an application to transfer into a course / college for which they are responsible from another course at JSS AHER.
- 2. When making decisions on applications to transfer between courses, factors that JSS AHER considers include:
  - a) Prerequisites and other admission requirements for the course
  - *b)* The availability of seat as per statutory policy;
  - c) Regulatory requirements/Approvals (UGC/MCI/DCI/PCI/AICTE/RCI/AERBJSS AHER)
  - d) The minimum entry requirements for the course; and
  - e) The academic competitiveness of the applicant.

### **Procedural principles**

### Selection / counseling committees' composition and procedures

- 1. The regulations of MCI/ DCI/ PCI/ AICTE/RCI/AERB and directions of Hon'ble Supreme Courtof India, states that all admissions to the professional courses should be made in accordance with the merit prepared with a conduct of entrance examination.
- 2. The regulation of MCI/ DCI/ PCI/ AICTE/RCI/AERB provides that where an institution of All India character is there, such as JSS AHER, the institution has to conduct entrance

examination on All India basis and admit students. However the admissions to medical / dental UG/PG programs will be based on the NEET eligibility as notified by the government of India/NMC /DCI and MCC of DGHS.

- 3. Admission Notification through print media and JSS AHER's website
- 4. Admission on merit based on the rank list prepared by JSS AHER from the marks secured in the qualifying exam and or an entrance exam conducted by the designated authority of the Government of India / institution as may be notified from time to time by the Government of India / institution
- 5. Selection decisions must be made on the authority of a selection committee with due attention to equity and consistency.
- 6. The selection committee selects only from among applicants eligible for consideration under the minimum entry requirements approved by the Board, including the English standard for the course.
- 7. In determining eligibility, and in ranking eligible applicants, the selection committee will take into consideration:
  - *a)* the guidelines on the interpretation of resolutions on selection;
  - b) the rules for ranking applicants; and
  - c) the schedule on use of selection instruments, determined by the Committee and published on JSS AHER website.

### Assessment of Applications

- 1. Fair Admissions: JSS Academy of Higher Education & Research is committed to delivering a fair admissions system that admits students of outstanding achievement and potential, irrespective of their background. In so doing, we are committed to the 5 key principles of Fair Admissions as outlined in the Schwartz report: transparency, minimizing barriers to entry, selecting for merit, potential and diversity, professionalism and using assessment methods that are reliable and valid.
  - Selection Criteria: Applications will be assessed against academic selection criteria specific to the course of study for which an application has been made. Applicants are advised to check information on course specific entry requirements and details entrance test & admission process which are published on the JSS AHER website at

### Cancellation or withdrawal of offer

- 1. The Registrar may approve the withdrawal offer or cancel the admission and enrolment of a student where:
  - a) The candidate fails to provide documents or to fulfil other requirements specified in the offer of admission by the specified date;
  - b) The offer of admission has been made based on incomplete, inaccurate or fraudulent information provided by the person or a third party on behalf of the person;
  - *d)* The person fails to enroll in accordance with the offer of admission by thespecified date;
  - e) The person arrives late for a teaching period or does not engage with or genuinely begin his or her studies before a date determined and advised by JSS AHER;
  - f) In the reasonable opinion of The Registrar the authority is holding open, or intends to hold open, his or her offer or enrolment for purposes other than genuine study;
  - g) The Registrar determines that it is necessary orreasonable to withdraw the offer in order to fulfil regulatory or administrative requirements or guidelines; or
  - h) The Registrar becomes aware that appropriate supervision or other resources are no longer available to support the applicant's admission; or
  - i) The course is withdrawn from offer as a result of JSS AHER decision.
- 2. Any action taken under admission section must be notified in writing to the student.

#### FEE POLICY

Purpose

- The JSS Academy of Higher Education & Research (JSSAHER), Mysuru operates sustainably as a not-for-profit organisation. It reviews and publishes its fee structure annually.

- The policy has been developed to enable students to make properly informed decisions and aims to assist students in the payment of fees.
- This policy explains ways in which students can settle the fees and the refund policy.
- It outlines the consequences of non-payment of fees.
- This policy statement is designed to ensure compliance with all applicable regulatory requirements of bodies.
- The policy is reviewed annually, and students will be informed to the terms of this policy as part of the registration process at the start of each year of study. Details of any changes made to this policy will be made available through the website of JSSAHER (www.jssuni.edu.in).

#### Scope

• The Fee Policy applies to all the students (including applicants, where applicable) of JSSAHER, Mysuru.

### **Principles of Fee Structure**

- JSSAHER, Mysuru will ensure that the Policy on Fee structure is operated fairly and consistently across the constituent colleges and departments of JSSAHER.
- In addition to tuition fees, students may be required to pay other charges. These are costs levied by or on behalf of JSSAHER, Mysuru and may include charges for labs, library, exam and breakages among others. Additional charges and the terms and conditions which apply to those charges will be published periodically and communicated to students.
- Students retain ultimate liability for the payment of their fees, whether invoiced or not, including where sponsorship agreements have been approved.
- Students will pay the entire fees at the time of their initial enrolment on the programme
- Under exceptional circumstances JSSAHER, Mysuru retains the right to provide for payment of fees in instalments.
- Students, who fail to pay fees due, will not be permitted/eligible for admission to any of the examinations.
- No student shall under any circumstances be allowed to appear for examinations without furnishing the "No Dues" certificate to the Principal of the College/Co-ordinator of the Department of JSSAHER duly signed by the respective authorities.
- No degree or qualification of the JSSAHER, Mysuru shall be issued to a student who has not discharged all his/her financial obligations to JSSAHER, Mysuru.
- The university reserves the right to alter fees or other charges without notice.

#### **Roles and Responsibilities**

Students are expected to:

- Pay promptly any charges determined by JSSAHER, Mysuru, including tuition fee charges.
- Any representation by the students regarding payment of fees should be submitted at the time of joining the course and such application should include reason justifying the same such as application for education loans with a clear mention of the date on which fee shall be paid.

#### The JSSAHER, Mysuru will:

- Provide accurate and timely information to students about the fees associated with programmes of study at the JSSAHER, Mysuru and ensure that students are informed of any changes since they applied for the programme and before the decision is made to join the programme.
- Provide financial advice and guidance to students regarding fees.
- Comply with relevant guidelines / orders as per the requirements of statutory/regulatory bodies in respect to fee policy.
- Charge fees in advance only for the year in which a student wants to engage in academic activities, except the international students where the conditions are determined by the sponsoring/funding agency with which JSSAHER has agreement.

The Constituent Colleges / Departments of JSSAHER will:

- Be responsible for students' fees collection and each constituent college/department of JSSAHER should maintain DCB (Demand, Collection and Balance) towards the student's fee collection and are required to submit the fee collection details to JSSAHER, Mysuru periodically.
- Notify the fee payment notification with due date on the notice board or electronically periodically (semester / year wise) duly marking a copy to the Finance Division of the JSSAHER, Mysuru.
- Follow-up the collection status of fee from each individual student (semester / year wise) and submit report to Finance officer within 90 days of starting of academic year compliance to the fee collection.
- Intimate the students about their fee dues in the respective semester/year. If the fee has not been paid by the students, the department should submit the list of defaulters to the University with clear recommendations for further action. Also, the department should not issue "No Objection Certificate" to the students who have not paid their dues. The Head of the institution / Co-ordinator of the Department of JSSAHER will be responsible towards the collection of fees and adherence to the fee policy.

## **Refund of Fees**

It is as per the norms of the regulatory authorities/bodies, which is published periodically.

\*Date of admission means the date before which the student is to report for admission to the institution / committee / authorities and does not imply the last date of completion of admission process. The directions given by the competent admission authority with regarding to reporting date will supersede the above clause where specifically mentioned and withdrawal will entail loss of full fees or as may be imposed by the institution.

# 2.Constitution:

- 3. Vice Principal, JSS Medical College, Mysuru Member.
- 4. Vice Principal, JSS Dental College & Hospital, Mysuru Member.
- 5. Vice Principal, JSS College of Pharmacy, Mysuru Member.
- 6. Vice Principal, JSS College of Pharmacy, Ooty Member.
- 7. Coordinator, Dept of Health System Management Studies, JSS Academy of Higher Education & Research Mysuru Member.
- 8. Administrative Officer, JSS Medical College, Mysuru Member.
- 9. Administrative Officer, JSS College of Pharmacy, Mysuru Member.
- 10. Administrative Officer, JSS College of Pharmacy, Ooty Member.
- 11. Administrative Officer/ Superintendent, JSS Dental College & Hospital, Mysuru Member.
- 12. Resident Engineer, JSS Academy of Higher Education & Research, Mysuru -Member.
- 13. Superintendent Department of Water & Health Faculty of Life Sciences, JSS Academy of Higher Education & Research, Mysuru Member.

The maintenance committee shall meet thrice a year (July/November/April) and additionally as needed. Calendar dates and location of meetings will be decided by the committee on a yearly basis. Decisions of the Campus Maintenance Committee shall come in to action only with the approval of the Registrar.

Coordinator-IQAC, JSSAHER, Mysuru, shall be a special invitee for all the meetings and activities of the committee.

## 3. Responsibilities:

- 1. Maintenance organisation, which relates to creating an organisational structure for facilities maintenance, which shall clearly define duties and responsibilities, and should vary with the complexity of the University, colleges and departments.
- 2. Maintenance inspection, which relates to building examination in order to preparea maintenance plan and most importantly, gather information to form the basis for the maintenance programme, using various forms of inspection checklists for building structures including roofing, grounds and service systems.
- 3. Maintenance planning, which relates to formulating a maintenance strategy for achieving better use of facilities and minimising the cost of resources tied up in grounds and buildings.
- 4. Maintenance planning invariably includes maintenance policy formulation and aspects of maintenance funding.
- 5. To conduct meetings and to prepare and distribute meeting agendas and minutes of the meeting and to be familiar with University and Institutional structures, committee guidelines and activities.
- 6. To maintain vendor list related to Campus Maintenance.
- 7. To share resources amongst the constituent colleges and departments.
- 8. To review projections of future facility an infrastructure requirement.
- To monitor and advise on the Greening of the campus, waste disposal & management /recycling process etc.
- 10. To contribute in conservation and beautification of campus and to coordinate the upkeep of guest houses.
- 11. To support strategies and activities related to "Smart Campus Policy of JSSAHER"
- 12. To help revision of "Energy conservation & recycle policy "with annual audit.
- 13. To conduct awareness program on sustainable development goals & conservation
- 14. To facilitate "Help Desk" for the visitors to University and Institutions.
- 15. To conduct annual self-evaluation of the performance of the committee and the effectiveness and compliance.
