

Sir,

I am directed to enclose herewith a copy of the Notification no.F.9-9/2003-U 3(A) Vol.2 dated 7.02.2018 on the above mentioned subject and to inform you that the Ministry of Human Resource Development vide its notification No. 9-9/2003-U3 (A) Vol.2 dated 7<sup>th</sup> February, 2018 has on the advice of UGC accorded continuation / extension of deemed to be university status to 'JSS Academy of Higher Education & Research, Mysore, Karnataka for another period of six years w.e.f. 28.05.2013 to 27.05.2019 subject to the terms and conditions of earlier Notification no.9-9/2003-U3 dated 28.05.2008 and UGC (Institutions deemed to be Universities) Regulations, 2016 as amended from time to time:

The continuation / extension of deemed to be university status to JSS Academy of Higher Education & Research, Mysore, Karnataka is subject to fulfilment of following conditions:

- The Institution deemed to be university shall change the name of its Society, Land title, Accounts, Corpus Fund, etc., in the new name i.e. JSS Academy of Higher Education & Research, Mysore, Karnataka
- ii) The Institution deemed to be University shall incorporate the new name in all letter Heads, website and all its further correspondences.
- The Institution deemed to be University shall carry out other necessary changes as essential after change of name in accordance with UGC (Institutions deemed to be Universities) Regulations, 2016.
- iv) All the other conditions mentioned in the earlier Notification dated 29.05 2008 shall continue to be adhered by 'JSS Academy of Higher Education & Research"

The Ministry has further stated that the continuation/ extension of the above is further subject to fulfilment of the following conditions:

- The management of all the four teaching institutions mentioned in Para 2 of this notification shall be legally vested with 'JSS Academy of Higher Education & Research Society' created to manage the affairs of the deemed to be university.
- ii) All the moveable and immovable assets of all four institutions mentioned in Para 2 of this Notification shall be legally vested with the USS Academy of Higher Education & Research Society' and shall be registered as such in the interest of further of students, faculty, employee and for maintaining the standards of higher education.

- iii) The 'JSS Academy of Higher Education & Research Society' and the institutions concerned shall not undertake or engage in any activities that are of commercial and profit making in nature.
- iv) As and when necessary, the Institution Deemed to be University shall change its MoA/Rules as per the provisions of UGC(Institutions Deemed to be Universities) Regulations, 2016, as amended from time to time.
- v) The academic programmes being offered or to be offered by JSS Academy of Higher Education & Research will conform to the norms and standard prescribed by the UGC and other relevant Statutory Councils, as amended from time to time.
- vi) The Institution deemed to be University shall not offer/ award degrees that are not specified by the UGC. The Institution shall also ensure that the nomenclatures of the degrees, etc. to be awarded by it are specified by the UGC under section 22 of the UGC Act, 1956.
- vii) JSS Academy of Higher Education & Research shall start new courses/ departments/off-campuses/ off-shore campuses in accordance with the provisions of the UGC (Institutions Deemed to be Universities) Regulations, 2016, as amended from time to time.
- All the prescribed norms and procedures of the relevant Statutory Councils such as UGC, MCI,INC, PCI, AICTE etc and other authorities concerned in the matter of admission, students intake capacity, starting of new programmes/ courses, renewal of approval of courses, etc., will continue in force, shall be adhered to by JSS Academy of Higher Education & Research

You are requested to send the compliance in respect of the above conditions.
